Current funding

- In the FY 2007-2008 legislative session, the General Assembly appropriated another \$20 million, with \$15 million going to water and sewer infrastructure grants.

Eligibility

- Units of local government
- Rural counties, or distressed, urban counties (Tier 1 or 2)
- Urban Counties that are now eligible:
Alamance, Catawba, Cumberland,
Davidson, Gaston, Rowan
- Jobs must be created in the private sector

Eligible Award Amount

- \$10,000 per job created
- Maximum grant of \$500,000, or one-half of the infrastructure project costs, whichever is less
- 5% local match – cash or loan only, no in-kind

Covering the Infrastructure Costs

- The remaining 45% of the infrastructure cost can come from:
 - CDBG grants from the N.C. Department of Commerce
 - Appalachian Regional Commission
 - Private investment
 - Golden LEAF
 - Economic Development Administration grants

Accessing Rural Center Funds

- Local and private funds must be expended 100% before Rural Center funds can be dispersed
- Please note, **ALL** local funds must be expended, even if they exceed the 5% match requirement

Application Procedure

- The local government, or its designee, must complete and submit a pre-application form. We take pre-applications on a rolling basis.

Application Procedure

- The pre application form must include the following:
 - A project area map
 - A detailed project budget
 - A signature from the Unit of Local Government
 - If for any reason, a project is withdrawn from funding consideration, the Rural Center must be notified in writing

Application Procedure

- The Rural Center staff will notify you of receipt of the pre-application by email or phone within a week

Application Procedure

- The Rural Center staff will review the pre-application, check the budget, and schedule either a meeting or a conference call between the Rural Center, the local government, and the business(s) creating the jobs

Application Procedure

- The meeting or conference call is meant to clarify the conditions of our Performance Agreement. At issue:
 - Timetable for creating the jobs, and how jobs are counted
 - Claw-back provision should the jobs not be created

The Meeting/Conference Call

- If the results of the meeting are that all partners agree on the conditions of the Performance Agreement, and all funding is in place, we make a recommendation to our Board to invite that local government to submit a full application and an executed Performance Agreement

Full Award

- If approved for funding by the Rural Center Board, an award will be made contingent upon Rural Center staff receiving and approving a completed application and an executed Performance Agreement

Contracting

- Projects must be contracted with the Rural Center within 6 months of the award
- If a project is not under contract within 6 months, the funds will be de-obligated

Contracting

- A community is welcome to re-apply for funding from the Rural Center when all funding is in place

Contracting

- Projects are expected to be completed within 3 years of being contracted with the Rural Center

Potential Increases in Award Amounts

- If a community needs additional funding from the Rural Center, this request must come in writing from the Unit of Local Government
- Please attach a revised budget and a justification of the increase in cost with the request

Potential Increases in Award Amounts

- This request will have to go before the Rural Center Board and it is subject to availability of funds
- Keep in mind, if you request additional funds, you must commit to additional jobs and the Performance Agreement must be revised

Counting Jobs

- At the time of grant award, we will request a baseline job count of the business(s) involved in the project

Counting Jobs

- Once the grant award has been made by the Rural Center board, jobs created can be counted towards satisfying the business job commitment as defined in the Performance Agreement

Counting Jobs

- We use the NC UI 101 form for unemployment insurance payments
- We will request an NC UI 101 form for the quarter during which the grant award is made – this is the baseline head count

Counting Jobs

- **IF** the NC UI 101 form won't suffice, we will accept certification from the Human Resources Director or equivalent position for job counts at the following intervals:

Counting Jobs

- When the grant award is made, i.e. the baseline count,
- One year after substantial completion, or
- When all jobs have been created
- And a final time 6 months after all jobs have been created

Counting Jobs

- Should the jobs contracted in the Performance Agreement not fully materialize, the Rural Center will attempt to reclaim funds through the local government

Two Contracts

- Performance Agreement – between the business owner and the local government
- Contract between the Rural Center and the local government

- We can fund retail and service jobs, as long as they are full-time (35 hours per week minimum), and pay at least minimum wage
